## COMPETITION FORMAT AND RULES BEACH VOLLEYBALL

As of 23 JUN 2014

### Youth Olympic Competition Format

The Youth Olympic competition for Men and Women consists of two phases - the preliminary phase and the final phase.

A total of 36 men and 36 women grouped in two-athlete teams will take part in the competition. In total, 228 matches will be played (114 men's and 114 women's).

Seeding of the teams and pool allocation will be determined by a draw to be conducted by the FIVB in cooperation with NYOGOC no later than one month before the start of the competition.

#### Preliminary phase

The seeding

The preliminary phase will consist of six pools of six teams each in a round robin format. The process of allocation of teams into the pools will be defined by the FIVB. Every team will play the five other teams in their pool. The ranking of teams within their pools will be determined by the total number of match points, with the following points awarded per match to each team:

Match won	2 points
Match lost	1 point
Match forfeited	0 points (21-0; 21-0)

A total of 90 matches will be played for each of the men's and women's competition in order to determine the pool ranking.

The first four ranked teams from each pool advance automatically to the final phase.

A total of 24 teams will qualify to the final phase for each of the men's and women's events.

#### Final phase

The 24 men's and 24 women's teams advancing to the final phase will play a single elimination system. Seeding of the teams will be in accordance with FIVB regulations, with the eight best ranked teams from the preliminary round being seeded directly into the round of 16. The round of 24 will comprise eight matches, with the winners then being drawn into the round of 16 in accordance with FIVB regulations.

The winner of each match advances to the next round. The losers of each match are eliminated. The winners of the two semifinal matches advance to the gold medal match. The winner of this match is awarded the gold medal and the loser is awarded the silver medal. The losers of the two semifinal matches compete for the bronze medal.

### Differences between the Youth World Championships and the Youth Olympic Games

The competition format is similar to the Youth Olympic Games. The Youth World Championships currently have 32 teams per gender.

### Changes since the Singapore 2010 Youth Olympic Games

Not applicable, first appearance in Nanjing.

### Sport Rules and Procedures

#### Scoring

With the rally point system (sometimes referred to as RPS) the team winning a rally scores a point regardless of which team is serving. When a team wins a rally, it gains a point and the right to serve. The match format for international



Beach Volleyball competitions is to the best of three sets, the first two sets are played to 21 points, and the third set if needed is played to 15 points, with all sets requiring a two-point advantage (unlimited).  
At the completion of each match during pool play, 2 points will be awarded to the winner, 1 point will be awarded to the loser, and 0 points will be awarded to a forfeited team.

### **Ties (Ranking in pools)**

Ranking in pools will be determined by the total number of points. If a tie should occur during the team ranking process, the following processes will be followed.

During the preliminary phase:

- If the teams are tied in the match points, then the ties will be broken by the rally points ratio of all played matches in the pool
- If a tie still exists then the teams have the same position in the ranking

At the end of the preliminary phase:

Between two teams:

- The winner of the head to head match is ranked higher

For more than two teams:

- If the teams are tied in the overall match points, then the ties will be broken by the match points in the matches between the tied teams
- If the teams are still tied, the ties will be broken by the rally points ratios in the matches between the tied teams
- If the teams are still tied, the ties will be broken by the rally points ratios in all matches in the pool
- If a tie still exists then the teams ranking is determined by the draw

### **Draw for the Final Phase**

The first four ranked teams from each pool (twenty four teams), will qualify to the final phase. These teams will be ordered into three groups (seeded group, group 1 and group 2) by their ranking in the pool round as follows:

- The seeded group (eight teams) will be composed of the winners of each pool, plus the two best second ranked teams. This group will advance directly to the round of 16.
- Group 1 (eight teams) is composed of the four remaining second ranked teams, plus the four best third ranked teams from the pools.
- Group 2 (eight teams) is composed of the two remaining third ranked teams, plus the six fourth ranked teams from the pools.

The teams from group 1 and group 2 will be drawn into the round of 24 (eight matches), respecting the following conditions:

- Teams from the same pool in the preliminary round must not meet in the round of 24
- Teams from the same pool in the preliminary round must not meet in the round of 16. Therefore neither team in a match in the round of 24 may come from the same pool as the seeded team that the winner of that match will meet in the round of 16.

### **Penalties / Disqualification Rules**

In accordance with the FIVB Official Volleyball Rules

### **Protests / Appeals**

Disputes will be resolved under the FIVB regulations. The FIVB Control Committee will make decisions in accordance with the FIVB regulations.
